Application Information for School Year 2010-2011

Thank you for your interest in Oneonta Cooperative Nursery School. If you have decided that this may be the right school for you and your child, the application process is your next step. Your child is eligible to apply if he/she was born on or before December 2, 2007 and will be toilet-trained by September 2010.

The application for 2010 - 2011 is attached. Please read it carefully and complete each item legibly and in ink. Next, attach a check to your application in the amount of \$50.00 (non-refundable) payable to Oneonta Cooperative Nursery School. Enclose both items in a stamped envelope and send through the regular U.S. Mail to:

****Upon receipt, I will assign your application a priority number. If more than one application is received on the same day, priority numbers will be randomly assigned.****

Within three to four weeks of receipt of your application, you will receive one of two possible letters:

1. If your child has been placed in a class, you will be sent a placement letter and several important forms which need to be completed for our records. You will be given fifteen (15) days in which to return these forms and a deposit of one month's tuition and the earthquake kit fee in order for your child to be officially accepted.
2. If the class for which you applied is already full, your child will be put on the waiting list for that class. You will receive a letter confirming your child's status.

1. We will work classroom participation days in proportion to the number of days per week our child is enrolled. (This is to be fulfilled by either the mother or father of the child enrolled. Any other person must have prior approval by the staff and parent board before they are allowed to work in the classroom. NO EXCEPTIONS.)
2. We will work a mandatory three hours per semester on workday assignments.
3. We will attend Orientation, four mandatory General Membership Meetings throughout the year and at least two mandatory parent education meetings.
4. We will participate in all fundraising activities as approved by the General Membership, currently including the Spring Benefit, and other activities.
5. We will serve in one school Aide position or as a Board member.
6. We will purchase an Earthquake Kit, as provided by the school, for our child.
